UIO Performance

Notification Performance

- On Time: Notifications completed within the legislated timeframe (standard and advanced requests) presented in volume and percent by region;
- Late: Notifications completed outside of the legislated timeframe (standard and advanced requests) presented in volume and percent by region;
- No 360 Feedback Response Provided: Notifications that have not been updated with a status and closed date in 360 Feedback presented in volume and percent by region.



Renegotiated Date

The number of notifications that have been renegotiated within the reporting period presented in volume and percent by region.



Day to Close Breakdown

The volume and percentage of notifications completed and how many days it takes for the member (UIO) to complete the notification.

- 0-5 Business Days: Considered On Time for all requests;
- **6-10 Business Days:** On Time for advanced requests but late for single-address requests (which must be completed within 5 days);
- 11-15 & 16+ Business Days: Late

Key Definitions

Underground Infrastructure Owner (UIO) Name

Underground Infrastructure Owner is a Member of Ontario One Call. A person or entity described in one or more of the following paragraphs is a member of the Corporation if the person or entity owns or operates underground infrastructure:

- 1. Every municipality in Ontario;
- 2. Hydro One Inc., as defined in the Electricity Act, 1998;
- 3. Ontario Power Generation Inc., as defined in the Electricity Act, 1998;
- 4. Every gas distributor and every gas transmitter, as those terms are defined in the Ontario Energy Board Act, 1998;
- 5. Every Operator of a distribution system, as defined by the Electricity Act, 1998;
- 6. Every person or entity regulated under the Oil, Gas and Salt Resources Act;
- 7. Every person or entity that owns or operates underground infrastructure that crosses a public right of way or is in the vicinity of a public right of way.

Renegotiated Data

When the Member (UIO) and the Excavator have mutually agreed in writing to a different due date for a standard or advanced locate request, where such renegotiated date:

- a. reflects an actual agreement between the Member (UIO) and the Excavator confirmed in writing during the first five
 (5) business days (for a standard locate request) or during the first ten (10) business days (for an advanced locate request) from when the Member (UIO) received notification of the locate request;
- b. is recorded by the Member (UIO) in 360 Feedback or in a manner otherwise expressly permitted by Ontario One Call, by, at a minimum:
 - i. Changing the locate status to "renegotiated"
 - ii. Entering the agreed-upon renegotiated date;
 - iii. Entering details about the renegotiation including, but not limited to, the Member's (UIOs) and the Excavator's representatives, by name, who agreed to the new date, and the actual date the agreement was made.



Points to note

- Data shown on pages 1-3 displays performance data combining both standards and advanced requests.
- Data on pages 4-6 and 7-9 display the performance data for Advanced and Single requests respectively.
- The report template design has been updated to enhance reporting clarity and user experience. Changes include the addition of a cover page, improved layout and streamlined visualizations. These updates are intended to improve accessibility and provide a more comprehensive overview of the data.
- The new legislative change, Ontario Regulation 136/24, took effect on May 1, 2024. It would have impacted the data starting from the last week of April 2024. Consequently the numbers may not add due to rounding.
