
#### **Preliminary Checklist**

- ✓ Ensure your DL Contact information listed on your '**Notification Instructions**' is up-to-date.
- Confirm you have a web portal username associated with your station code(s). Contact the DL team  $\checkmark$ if you need to register a web portal username.
- Establish a process for responding to a DL Notice within 10 business days  $\checkmark$
- Review each 'Notice of Dedicated Locator Project' email sent from Solutions@OntarioOneCall.ca.  $\checkmark$
- Keep an open line of communication with the DL team, the project owner, and the DLSP.  $\checkmark$

#### Steps for updating Infrastructure Owner decision of proposed DLSP



- 1. Log in to the web portal.
- 2. Basic Search: Click on the 'Request Search' box, enter the 'DL Notice Request #', & click 'Search'



- 3. Review the 'Notice of DL Project' and take note of the following changes:
  - Project Owner
  - Dedicated Locator
  - Larger map selection(s) to encompass the entire Project area
  - Amount of different projects within the proposed area

- 4. Contact the Project Owner or the Ontario One Call DL team directly if you require clarification.
- 5. Agree in writing with the Project Owner upon the DLSP.
- 6. Provide the DLSP with mapping and other information required.
- 7. When you are prepared to provide your decision of proposed DLSP click 'Edit Request'.



8. Scroll to the 'Infrastructure Owner Decisions of preferred DLSP' section and click on 'Edit'.

9. Click on "**DL Notice Sign Off**" on the '**Choose the action to perform on the request**' pop-up box that appears.

#### 10. Select a Status from the drop-down menu.

- > Written Agreement Obtained. This indicates that UIO has complied with the OUINS Act.
- > More Information Required. UIO requests additional information from the DL Notice.
- > Standard Locate Required. This Station code is an exempt Transmission or Unaffected UIO.

If you have selected WRITTEN AGREEMENT OBTAINED, you must confirm that the following have been completed:

(a) the affected members and the project owner shall agree in writing on a locator who will respond to all notifications made by the Corporation under clause (9.1) (a) in respect of the project; and

(b) the affected members shall give to the dedicated locator mapping information, such as the location of the member's underground infrastructure, and any other information that the dedicated locator considers necessary. 2022, c. 9, Sched. 2, s. 6 (1); 2024, c. 1, s. 9 (2).



# It is important to note that selecting WRITTEN AGREEMENT OBTAINED confirms that you have complied with paragraphs (a) and (b) of subsection 7 (7) of the Ontario Underground Infrastructure Notification System Act, 2012.

- 12. Enter additional information into the '**Notes**' field.
- 13. Click 'Confirm'
